Thank you to the Board consisting of Rev. The year 2020 will go down in history as the one that the COVID pandemic was the dominant concern all over the world and of course affected our Church greatly as well. In person worship and other activities in the church building were cancelled according to the government regulations. There was a short 4 week opening for worship in the fall until a further lockdown occurred. Strict health regulations were followed throughout all of these times and a thank you goes out to those involved in getting our Church set up with signage, etc. to do that.

A telephone phone tree was established by the Board to keep in touch with all of our members throughout this difficult time. Also a coffee chat via Zoom is held following each Sunday online service for anyone wishing to take part. We need to keep encouraging each other and our faith community is a good way to reach out to others. Without regular in person worship, we lose that personal contact that we all need.

We are grateful for the combined efforts of the other United Churches in the City without Ministry who have worked together to provide online regular Sunday worship. This has been very well received by all who can access it. The five congregations have taken turns being in charge of the worship including the music which has moved around as well. This has been a lot of work for our music director Jill Schutte and Sharon Loghrin so without them, this would not be possible.

Thank you to everyone who continued financial support through these difficult times so that we could stay on top of our ongoing expenses even though we were unable to hold our usual fundraising events (spaghetti suppers, green thumb tea, country Christmas tea) and our beloved Café del Soul lunches.

The other major thing that the Board dealt with this year was the resignation of Rev. Rob Smith as our Minister in April. We were disappointed that he wouldn't be staying with us for longer as we were just getting to know each other . However, he was offered a full time job with the Canadian Shield regional office that he felt called to accept. We appreciate his leadership and good humour while he ministered with us. A search team to look for a new half-time Minister has been put in place, but in these uncertain times, it is difficult to get interest from anyone outside our community for part time work. The committee put together a new video to describe what we are about at Pinegrove (thanks to Jill Schutte) which is available through our website and the Church Hub. Check it out – some great pictures!

The highlight of the year had to be the new Trail of Lights event held in early Dec. spearheaded by Michelle Kolobutin and her able volunteers of all ages! Outside and safe for all, the community responded with appreciation by donating over \$1,500 plus a truckload of food to the Rural Cupboard Food Bank. A fun event all around! Let's look forward to better days ahead in 2021 for us all when we can come together to worship and see each other in person again.

Minister's Report

February 2021

"Have you not known? Have you not heard? The Lord is the everlasting God, the Creator of the ends of the earth. God does not faint or grow weary; God's understanding is unsearchable...Even youths will faint and be weary, and you will fall exhausted; but those who wait for the Lord shall renew their strength, they shall mount up with wings like eagles, they shall run and not be weary, they shall walk and not faint." – Isaiah 40.28-31

It is hard to believe that it has "only" been a year since our last Annual Meeting. It feels like a lifetime ago. It has been an exhausting year and many of us, myself included, feel weary from the journey. I take comfort in these words from our sacred text because they remind us that our God is an everlasting God. God has not and will not abandon us. God was with us through this pandemic and God will be with us as we find our way forward on the other side. These words from the prophet Isaiah also remind us that God will not leave us weary and exhausted. God promises to renew our strength and enable us soar like the eagles. All God asks of us is to wait upon God; to take time to let God speak to us and renew us.

Here are some of the ways that I saw God strengthening us as a community of faith and enabling us to soar like the eagles in this past year:

- January and February and early March we continued to offer great lunches and meaningful community to our neighbours through our Café del Soul program. I hope that we will be able to start that program again soon. I am still committed to doing my lunch of beans and wieners.
- When the pandemic hit we found new ways to stay connected to each other by calling each and checking in once a week through Zoom. I have many fond memories of our virtual coffee hour after the livestreaming service.
- We also found ways to offer our gifts to the larger church as we joined other United Churches in Thunder Bay in creating a weekly live-streaming service. One of my favourites was our camp service that we taped at Jill's camp in early July. I have also been blessed by our choir and our leaders for their part in these services. I have been amazed at your willingness to learn

and do new things and embracing new technologies. We have touched more lives by working together in this way than we could ever hope to touch by working separately. I pray that we will continue to find ways to work together. We showed ourselves that change is something we can do and that we do not need to be afraid of change.

- We also found ways to reach out to our community by putting on a Christmas light show and inviting folks to drive thru our displays and offer support for the Rural Food Cupboard. Well done
- You also found a way to say good bye to me as your minister that was special and meaningful.

We have already learned how to soar. Each of these events are signs that God did not abandon us. God has walked with us even through this pandemic and we are stronger today than we were a year ago. God will continue to be with us no matter where the journey takes us.

Thank you for the opportunity to be your minister this past year. It was an amazing privilege. My prayers are with you as you embrace whatever the next chapter brings to you. I know that the everlasting love of God will enable you to soar like an eagle, run and not be weary and to walk and not faint.

ANNUAL REPORT OF THE PASTORAL CHARGE SUPERVISOR

In August 2020 I was named as Pastoral Charge Supervisor for the Pinegrove Pastoral Charge, as the Minister was reassigned to Regional Council duties and employment. In many ways this was 'coming home' for me as I had been the supervisor, on and off, since about 2009, working when there was no ministry personnel as well as with several ministry personnel: Rev. Scott Gale who was in Admissions at the time, and Rev. Hubert den Draak who was a student for several years until he was commissioned.

At the death of Rev. Gale, I was reassigned as PC Supervisor until Rev. Rob Smith answered the call to Pinegrove. Now, again, I am serving as the PC Supervisor.

The Pinegrove Board and Congregation are a very faithful, active and community-minded group. Their dedication to the community of the church as well as the community in which they are situated is commendable. Local outreach is high on their list of projects, activities and support.

Worship through 2020 has been as part of the Trinity Live-streaming Hub, with Pinegrove hosting the weekly service approximately every five weeks, in rotation with the other participating congregations. As the `host` congregation the Pinegrove Worship Committee ensures that there is a worship leader, and that each element of the service has participants in place, from the whole worshipping community. Members of the Pinegrove congregation readily offer music as well as reading for the different elements of a service. This partnership in the United Churches of Thunder Bay technology hub has kept members of the congregation of Pinegrove part of the worshipping community and has offered new connections with other participating congregations.

The Board continued t meet through the COVID year, by using ZOOM, dealing with issues as they arose, and addressing the usual administrative aspects of congregational life, with efficiency and care. Board members have become comfortable with the ZOOM meetings technology and, except for the refreshment aspect (!), business is addressed thoroughly and respectfully.

Christian education opportunities have been few, onsite, but several members sometimes participate in the weekly lexionary Bible study offered in our Region. I have no concerns with the life and activities of the Pinegrove United Congregation and Board. A Search Committee has been formed and has uploaded the Pinegrove Profile and Position to the Church Hub. The waiting-for-response experience has begun. I look forward to on-site Board meetings (and those refreshments!) so that I may be an in-person part of aa thriving and successful community of the United Church.

Worship Committee Report, 2020

Well, this year certainly has been a different year hasn't it? When the worldwide pandemic of COVD-19 took over the world, church services were suspended in late March to follow government restrictions to try and slow the spread of the pandemic.

Our choir started to do recordings of hymns and anthems to send in to be composed into virtual choirs for weekly streamed online services. I contributed recorded Preludes, Offertories and Postludes when requested. This continued through the summer months.

In July, Rev. Rob Smith completed his time with us after taking on a new position, Pastoral Relations Minister for the Canadian Shield Regional Council. In August a Search Committee was formed to begin the process of finding a new minister.

In September, the music directors of Trinity, St. Paul's, Harmony and Pinegrove formed a committee to meet weekly and share the musical duties of each service. First Wesley decided to stay involved and take a service every 5th week. We also set up a worship team to take turns getting clergy and organizing readers for each service. Sharon Loghrin is our lead on that. This has been very useful in using everyone's talents to the greater good. The quality of the virtual choirs and services has been improving each week as everyone becomes more familiar with technology and the streamed Thunder Bay United Churches services are becoming very professional.

Pinegrove opened its doors to in-person worship, watching the streamed services, in October but were only able to stay open for 3 weeks, when we were forced to close by government restrictions. We celebrated Christmas with some wonderful steamed services and music with the church decorated and looking very beautiful in our videos.

Since then we have continued to contribute musically and with readers for each service. This will continue as long as necessary.

If one positive thing has come from this pandemic, it is that all the Thunder Bay United Churches have been working together to offer some wonderful and varied worship services.

TRUSTEES' REPORT FOR 2020

The Trustees meet at least three times a year, however this past year has been quite a different experience. As a group of four persons we often meet after Church services are ended. This past year we did meet over the phone but there was one in person meeting at the Church. We were sure to follow all the health guidelines.

At this meeting we perused the present insurance policy to be sure that it met all our needs at this time. The Board of Trustees is also responsible for the Investments. The principal of \$150,000 is invested with the bank where our accounts are held. As most of you will know interest rates are quite low. At the end of the year our investments were worth \$177,287.50 which is a little over \$27,000.00 of accumulated interest. We also have an investment account where accumulated interest is held so it can be used as needed to help with housing allowance paid to the minister. This allows money to be freed up to complete necessary repairs and maintenance to the buildings and grounds.

We would like to thank all of the various Property Committees over the years who have worked tirelessly to keep the buildings and property in good repair. Your hard work is much appreciated.

Outreach Committee Report

Mission & Outreach

This year gave us limits as to how we could collect items for our outreach project. For all the projects listed below we left bins and boxes between the entrance doors, where people could leave their donations more easily and without contact with anyone. Thanks to everyone who took that opportunity and made donations to the project.

Mission & Service

This year our M&S givings were up over and above our budgeted figure. Every year our givings are under the budgeted amount and we have to top it up to meet the budget. This is a first since I became treasurer, and it sure makes me happy to see that.

Milk Fund

This project suffered from the church being closed during this pandemic. Since a lot of our donations come if through donations in the Milk Bottle, the fund was below our budgeted amount when we are usually over and we had to top up the amount with \$342.05.

The Mitten Tree

This year because of the pandemic, the amount of items for the mitten was down. However the tree was still covered with a quite a few Mittens, Hats, etc. from the drop off items. These items are to be kept in a bin until such times as they are required.

Shelter House

A fair amount of donations of mitts, socks, hats etc. for the client gift bags were left in the drop off boxes this year. These donations filled the largest gift bag you could by to the brim. They were taken to the Shelter along with bags of food donations from the Café del Soul stores. They were thrilled at the shelter, and asked if they could take a picture of the presentation so they could put it up on Facebook.

Beendigen Crisis Home

A lot of donations again from the drop off boxes of mitts, hats, socks, (ladies & children's), coloring books, crayons, & books. This organization was very grateful to receive these donations. I got the impression they do not get as many donations as other charities like this.

Rural Cupboard Food Bank

This project suffered as all the others, as we could not drop off the donations. However the Trail of Lights in December put on by the children & adults and lots of helpers brought in many donations of money and food items so that they ended up with a truckload of food items and \$1500 to donate to the food bank. Many thanks to all who took part. Totally amazing!
